Rate & Price Variation: Airline prices & taxes remain subject to change at all times until payment has been received in full & your tickets have been issued. Deep Powder Snow Holidays reserves the right until final payment has been processed, to vary prices & rates in the event of changes in currency exchange or price increases made by our suppliers or airlines. All pricing, denominated in AUD, are subject to variation due to volatility in foreign exchange prices. Any variation to listed prices will be based on the rates available to Deep Powder Snow Holidays at the time the deposit is paid by the client and again on payment of the final balance. Our exchange rate at date of deposit is only taken into account for amount of deposit paid to overseas supplier. At any time clients can lock in the current package cost by paying the balance amount in full, based on Deep Powder Snow Holidays exchange rate at that time. If the cost of any service increases due to exchange rate fluctuations, tax changes, price increases or any other reason, you are required to pay the increase when notified by us. If you choose not to pay the increased price you may choose to cancel the booking. Please note that cancellation charges will apply. Deep Powder Snow Holidays is not liable for any price increases. All prices are subject to availability & can be withdrawn or varied without notice. Airline prices & taxes remain subject to change at all times until payment has been received in full & your tickets have been issued. Deep Powder Snow Holidays reserve the right to correct prices & rates in the event of consultant error.

**Quotations:** All prices quoted are valid at time of quote. All quotes are subject to availability & confirmation of the components at time of booking.

### **Deposit:** By making a payment on a booking you agree to Deep Powder Tours booking conditions.

A minimum deposit of \$500.00 per person is required within 7 days from booking confirmation. All deposits are non-refundable once received. Payment of deposit acknowledges acceptance of all booking conditions.

**Final Payment:** Is due no later than 70 days prior to departure, or 7 days from booking confirmation if booking is within 70 days. Should airlines impose ticketing time limits, fare withdrawal or fare or tax increase; full payment of fare & taxes may be required before this time. Failure by the client to pay the outstanding balance by the due date may cause the auto-cancellation of the booking whereupon the deposit paid by the client shall be forfeited. Final documents will not be released until the booking is paid in full. Late payment fees may be incurred on your booking.

**Itinerary:** The itinerary supplied with your final documents represents the products & services that will be supplied & supersedes any previous arrangements or understanding, whether written or oral.

## Payment Options: By making a payment on a booking you agree to Deep Powder Tours booking conditions.

**Direct deposit** – you will find Deep Powder Snow Holidays banking details on your statement. You must include your booking # & booking name on any direct deposit. Failure to correctly identify your payment will delay our ability to recognise it & lead to delays in processing. **Cheque** – Cheques will not be accepted within 10 days of booking departure.

Credit Card – We will accept payment by credit card with the signature of the cardholder authorising payment to their card. Your consultant can supply you with a form on which to provide this detail.

We charge the following surcharges on credit cards ....

- 1.5% surcharge Visa & MasterCard
- 3% surcharge American Express

**Cancellations:** Any cancellations must be received in writing. Minimum fees are:

- Up to 60 days prior to departure full deposit will be forfeited.
- Within 60 days of departure 100% of total paid will apply.

Deep Powder Snow Holidays cannot be held responsible for Snow Conditions. Holidays cannot be cancelled or amended on the basis of snow conditions without cancellation fees being payable. This includes lift operations which are subject to weather conditions & maintenance.

**Professional fees:** Deep Powder Snow Holidays charges the following non refundable fees. These professional fees are in addition to any fees which may be charged by airlines, accommodation providers, transfer suppliers or any other supplier.

\$30.00 Booking fee.

\$50.00 Booking Amendment: charged per person once a booking has been confirmed and deposited.

\$150.00 Booking amendment inside 14 days: charged per person for changes inside 14 days of departure.

\$150.00 Travel document re-issue: charged per person in addition to supplier re-issue fees.

\$150.00 Airline ticket amendment: charged per person in addition to any airline charges once a ticket has been issued by the airline.

\$30.00 Late payment: charged per week for any final payments not received by the due date.

**Responsibility:** Deep Powder Snow Holidays acts only as an agent for the People Camps and companies (Principals) providing or offering the means of travel, accommodation and other services and as such has no control over any services or products provided by these Principals. All bookings made are subject to the booking terms and conditions under which these services are provided. The Company and its Principals reserve the right, without liability or right of compensation, to prohibit or restrict any activity, or cancel or alter any service or itinerary component, without notice, in their absolute discretion. Deep Powder Tours will not be held responsible for the inability of the Principals to comply with any special request relating to age, medical conditions, physical ability or disability, dietary requirements, allergic conditions, smoking or non-smoking accommodation.

**Travel Insurance:** Travel insurance is highly recommended for all holiday packages. Travel insurance can be purchased from Deep Powder Tours. Please ask your consultant for information and policy details. We suggest taking out your policy at the time of deposit, to cover you for cancellation fees in the event of a cancellation (conditions apply relating to coverage – always refer to the PDS). You may opt to purchase travel insurance elsewhere or you may have cover from a credit card policy. We will ask for your policy number if this is the case. Always read the PDS to ensure that you have the correct coverage. Any claims made under travel insurance & presented to Deep Powder Tours for product/services confirmation must be on the appropriate claim form provided by your insurer.

**Transfers:** Any transfers missed or not utilised by the client are non refundable. The cancellation policy of each service provider will determine whether a missed transfer can be moved to an alternate time/date. Cancellation fees may apply to date or time changes of transfers. Deep Powder Tours reserves the right to amend departure times & service providers at our discretion. You will be notified by Deep Powder Tours should this occur.

**Lift passes:** Lost or stolen lift passes are neither refundable nor replaceable.

**Airfares:** Can be purchased through Deep Powder Snow Holidays as part of your travel package. The conditions for the purchase of the airfare will be dependent on the airline & airfare that you are booked on and will be advised to you by Deep Powder Snow Holidays at time of quotation and confirmation. All fares quoted remain subject to availability at time of booking. Luggage limits apply to all airlines as per your itinerary. Additional fees for sporting equipment (skis, snowboards, surfboards, bicycles, golf clubs etc) may also apply. It is the passenger's responsibility to:

- Ensure correct spelling of names for persons travelling is advised to Deep Powder Tours at time of booking on the booking form & correctly shown on your itinerary.
- Ensure that any infants or children are booked into the applicable age category that has been quoted to avoid being charged a higher age category airfare at time of check in.
- Provide Deep Powder Tours with flight details for any flights not booked with Deep Powder Tours & ensure these details are shown correctly on your itinerary.
- Advise Deep Powder Tours of any changes to the above supplied flight details & ensure that these details are shown correctly on your itinerary.

**Passports:** Most countries require 6 months validity on your passport from the date that you depart their country.
